The criteria for participation in this program are:

Required:

- Each school is located in an area where T-Mobile has 4G LTE coverage over at least 80% of the school's geographic enrollment zone. T-Mobile will validate eligibility for this requirement; to see coverage in your area please check our coverage map.

Preferred:

- At least 40% of students receive free or reduced lunch at each school
- At least 5% or more of students are dropping out of high school (aggregate for all high schools if a school district is applying)
- At least 15% of students are not grade-level proficient in math and reading by the 9th grade (aggregate for all high schools if a school district is applying)

T-Mobile will select participants based on the criteria, the application and an interview.

T-Mobile's EmpowerED 2.0 program provides off-campus devices and data plans to help schools and students succeed. Students must be permitted to take home the devices offered through EmpowerED 2.0.

EmpowerED 2.0 Mobile Equipment includes:

- Hardware awards: From \$100-\$200 towards mobile Internet equipment, per participating student, based on the data rate plan selected.
 - Mobile Internet equipment may include: a hotspot, Chromebook, tablet, data stick, laptop or other device.

EmpowerED 2.0 Mobile Data Plans include:

A two-year contract for one of the following discounted education data plans:

1. Unlimited LTE for \$20/month: Unlimited 4G LTE data on our network.
2. 2GB for \$10/month: Up to 2GB LTE data on our network, followed by data reduced speeds up to 128kbps.
3. 2GB for \$0/month: Up to 2GB of LTE data on our network, followed by data at reduced speeds up to 128kbps. T-Mobile will award a limited number of free plans at its sole discretion.

During congestion, the small fraction of customers using >50GB/mo. may notice reduced speeds due to data prioritization. Video typically streams on T-Mobile device at DVD quality (480p).
