

T-Mobile Truck Ticket Giveaway Official Rules

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE
YOUR CHANCES OF WINNING.**

T-Mobile Truck Ticket Giveaway (the “**Promotion**”) runs from October 1 to October 11, 2018 (“**Promotion Period**”). The Sponsor’s clock will be the official timekeeping device for the Promotion.

ELIGIBILITY: The Sponsor of this Promotion is T-Mobile USA, Inc. (“**Sponsor**”). The Promotion is open to legal residents of the 50 United States and the District of Columbia 18 years of age or older at the time of entry who are located in game city area as specified in the tweet announcement (“**City**”). Void where prohibited. Employees, officers, directors, shareholders, agents and representatives of Sponsor and its respective parents, affiliates, and subsidiaries, as well as the immediate family members (defined as parents, spouse, children, siblings and grandparents) and those living in the same household of each such employee, officer, director, shareholder, agent, and representative are not eligible to enter.
